To Whom It May Concern:

On September 15, 1991 four service Areas known as Granite State, Seacoast, Southern Maine and Central Maine formed the Northern New England Region Service Committee of Narcotics Anonymous. The formation of this new Region grew out of the restructuring process within the New England Region that began May 7, 1989. Last year the Mountain Valley region emerged from this process and was seated at WSC '91. Our member Areas have participated in the New England Region Ad Hoc on Restructuring as well as Area level Ad Hoc Committees on Regional Growth. Attached you will find a brief history of the restructuring process including Area participation at both Area and Regional meetings, a map to identify the Areas and Minutes from our meetings. Guidelines are in the final stages and will be forwarded.

It is our intention to be introduced by the New England Region to the WSC as a new Region at the World Service Conference in April 1992. At that time we will ask to be recognized as a voting participant. We respectively request that the Policy Committee include our introduction and request for voting participation as an Agenda Item for the April World Service Conference at Dallas, TX.

The Northern New England Regional Service Committee meets on a monthly basis and continues to support the New England Region both spiritually and financially.

Nominations for Trusted Servants were taken at our October meeting and again prior to elections at our November meeting. All trusted servants positions were filled by members from the four Areas. Also elected were chairpersons to the following functioning subcommittees: H&I, PI, Literature, Outreach and Activities.

The Northern New England Region was formed in the belief that the Fellowship within the member Areas will be better served by a smaller, more efficient service structure. We will also continue to reach out to the Northern Maine Area to help them determine their needs.

We gratefully acknowledge the support and direction received from the New

England Region and look forward to serving the members of our Region as well as the Fellowship as a whole.

To Whom It May Concern:

The Granite State Area has been an active participant in the restructuring process within the New England Region for the past 30 months. Our Area was formed in 1990 when the original Four Seasons Area grew into three Areas after spending over a year researching the move. Currently we enjoy a membership of 31 groups with 36 meetings per week. Our members are active at the Group, Area, Region and World levels. We are familiar with growth and the need for change in order to better serve the recovering addicts in our Area. To this end we have participated in the ongoing regional growth process. We formed an Ad Hoc Committee On Regional Growth to determine the feasibility of leaving the New England Region because of the size of the Region and the associated problems we faced getting our needs met. The Ad Hoc Committee recommended joining the Mountain Valley Region. It was the feeling of the Ad Hoc Committee that we were too small to be a New Hampshire Region and the Maine Areas had not yet determined a direction for their move and were still gathering information. A group conscience directed the Area not to join the Mountain Valley Region and formed a second Ad Hoc to seek out other Areas to form a new Region. At this time communication lines were opened to all interested Areas. We also continued to meet at the New England Region Ad Hoc meetings on Regional Growth and took the direction and support that was offered. The result of this work culminated in the formation of the Northern New England Region September 15, 1991 at Lewiston, Maine.

Our groups voted unanimously to support this move and we look forward to the continued growth of Narcotics Anonymous in Northern New England. It is our feeling that our loving and caring Higher Power has enabled us to reach this point. More will be revealed.

In the process of forming a new region, we have been requested to submit information about our area. Please refer to the Northern New England Region letter of December 14, 1991 regarding this process.

The Seacost Area of Narcotics Anonymous was established in June, 1990 out of a restructuring process of the old Four Seasons Area of N.A. At that time, we started with nineteen groups and standing subcommittees which include: H&I, PI, Literature, Phoneline, Policy and Activities.

Today, all our subcommittees are filled except for Policy. The subcommittees are small but functioning to the best of their ability. H&I and PI have an operating budget that the Area funds. Our Activities subcommittee is self-supporting and provides a fund flow back into our service structure.

As a new Area, there has been some rewarding and trying times but through it all the principles are prevailing. We are carrying on with our primary purpose - to help our groups and to carry the NA message to the addict who still suffers.

After many New England Regional Growth Adhoo meetings, the information was brought back to the Seacoast Area and then distributed to the groups. On September 8, 1991, the group conscience was to join the Northern New England Region. This decission was made on the basis of what was best for our Area.

The Northern New England Region formed on September 15, 1991. The Region consists of the following Areas as of this writing: The Seacoast and Granite Areas of NH, the Central Area of Maine and the Southern Maine Area.

RE: C.A.M.N.A.'s involvement in the Northern New England Region

The Central Area of Maine N.A. wishes to inform you of our involvement in the creation of the Northern New England Region of N.A.. C.A.M.N.A. now consists of twenty groups, that we are in contact with, spread out over an area from Gray Me. north to Skowhegan Me., from the Maine/New Hampshire border, east to Belfast Me.. Although much of our Area is rural in nature, we have found that there is a spiritual bond that bridges any distance traveled for recovery from active addiction.

We formed as an area in August of 1989, the restructure process of the New England Region was already in process at that time. Our Area became involved in the restructure process when we formed an ad-hoc committee on regional growth at the December 1990 ASC, to explore the need and feasibility of becoming a smaller region. This process has culminated with a unanimous group concious decision to become part of the new region at the September 1991 ASC, having since been named the Northern New England Region.

In summation, recovery from the disease of addiction is a reality in the Central Area of Maine. We feel that this new region will prove to be the most effective way to carry the message of recovery to addicts and groups in Northern New England and Narcotics Anonymous as a whole.
